




LOCATION MAP

- If the fixed object or approach end of the temporary railing is less than 15'-0" from the edge of traveled way, a temporary crash cushion is required in a construction or work zone.
- Temporary crash cushion arrays shall not encroach on the traveled way.
- Arrays for median shoulders shall conform to details shown on this plan for outside shoulders.
- Place the Type P marker panel so that the bottom of the panel rests upon the pallet and faces traffic.
- Refer to Standard Plan A73B for marker details.
- For shoulder widths less than 8'-0", appropriate approved crash cushion protection, other than sand filled modules, shall be provided at fixed objects and at approach ends of temporary railing. The specific type of crash cushion shall be as shown on the project plans or as specified in the Special Provisions, or if not shown on the project plans or specified in the Special Provisions, shall be as approved by the Engineer.
- Approach speeds indicated conform to NCHRP 350 Report criteria.
- Use of pallets is optional.

2. The GFRP shall consist of triaxial fabric with the primary fiber oriented in the transverse direction of the bridge.
3. If any gap exists between ends of existing GFRP deck panels, build up to surface of existing GFRP deck panels with wet lay-up GFRP.
4. After cleaning, surface of existing GFRP deck panels must be exposed to provide bond with wet lay-up GFRP. Remove any existing paint or coating that would prevent bond.
- ⓐ Remove existing Type A joint.
- ⓑ Inspect joint for damaged polymer concrete.
- ⓒ Perform epoxy injection at damaged locations to repair polymer concrete.



ⓔ Apply 5 layers of tri-directional GFRP. Each layer shall extend 6" beyond the previous layer, see Note 2.



ⓖ Apply 3 layers of GFRP. Each layer shall extend 6" beyond the previous layer, see Note 2.

ⓗ Chemically clean bottom soffit 24" on either side of gap, see Note 4.

ⓓ Add resin filler to fill in existing 1/2 inch gap
